

# ALLOWANCES AND BENEFITS OF DIFFERENCE MEMBERS OF MUNICIPAL COUNCILS FOR 2023/2024 FINANCIAL YEAR (WITH EFFECT FROM 1 JULY 2023)

The purpose of report was for Council to note the response from MEC CoGTA and for Council to adopt and implement the recommendations of the MEC.

It was to be noted that the correspondence with reference to the Council's application from KZN Provincial – MEC CoGTA was attached to the agenda.

It was to be further noted that the KZN Provincial – MEC CoGTA, Rev TD Buthelezi had approved the level of payment of the Umdoni Municipality's Councillors' remuneration package at 95% of the percentage increase (i.e 2.85% increase) of the 2022/2023 financial year, Notice No 3807 dated 18 August 2023 of a Grade 3 Municipality.

Summary of questions of clarity were raised as follows: -

Cllr Cutten sought clarity regarding the financial year mentioned from the letter received from the MEC.


Cllr Naidoo commented on this item and advised that the concerns raised by Cllr Mdluli was the best however when referring to the issue of collection of rates it be noted that there was a group of residents who had been withholding rates but the question was who had been encouraging them to do so.

Responses on the clarity seeking questions, clarities were provided by the Acting Municipal Manager wherein he believed that CoGTA had applied a particular formula to calculate the increase with 95% of the percentage increase (i.e 2.85% increase) in respect of the 2022/2023 financial year.

Following much discussions and comments, it was,


