Notice is hereby given in terms of Chapter 5 of the Municipal Systems Act no 32 of 2000, Section 16 and Section 22 of the Municipal Finance Management Act, No.56 of 2003, read with Chapter 4 of the Local Government; Municipal Systems Act of 2000 as well as Section 14 of the Local Government; Municipal Property Rates Act that the Mayor of Umdoni Local Municipality, at the Council meeting held on 26th of March 2025, has tabled the Draft IDP, Draft Budget, together with Rates Randages and Tariff of Charges, for the 2025/2026 financial year which will be effective from 1 July 2025:

### D. DETERMINED THAT THE FOLLOWING REBATES WILL APPLY FOR THE 2025/2026 FINANCIAL YEAR AS FOLLOWS:

- All Developed Residential Properties The first R15,000 legislated and R60,000 as per council
  agreement on the market value of all developed residential properties will not be rated;
- 2. Vacant Property The first R15,000 on the market value of all vacant properties not utilized for industrial or commercial purposes, will not be rated;
- 3. On application all Disabled Persons, Pensioners and new Indigent applicants who have been declared as such in terms of the Municipality's Property Rates and Indigent Policies The first R 75,000 in terms of point 1 above and a further R 295,000 on the market value of the property will not be rated, closing dates for applications is 30 June 2025.
- Medium to high density level developments (sectional titles and shareblocks) will be granted a
  4 % rebate on rates due for the financial year;
- 5. Fixed and final date for the annual payment of the Assessment Rates for the 2025/2026 financial year is Thursday 31st October 2025, after which penalties, which shall be calculated at the bank prime lending rate plus 1%, will be levied.
- 6. Should you wish to pay rates on an annual basis you will need to make application by no later than 30th June 2025. All ratepayers that have paid their 2025/2026 rates in full by 31st October 2025 and have no arrears will be granted a discount of 3.5% on rates and refuse removal due for the financial year.
- 7. A 5% rebate will be granted on the following categories of properties: Residential, Industrial, Commercial, Agricultural and Yacant.
