WHEREAS Ugu District Municipality and Umdoni Local Municipality entered into a written agreement commencing on 01 September 2024 and terminating on 28 February 2025, a copy whereof is annexed hereto marked Annexure "G" (hereinafter referred to as the Principal Agreement), to regulate the payment of mobile toilets in Umzinto Informal Settlements.

And whereas the planned relocation of residents from Umzinto Informal Settlement to the Isonti Low Coast Housing by the Department of Human Serttlements and Umdoni Local Municipality is still experiencing delays. Due to these delays the construction of permanent VIP latrines remains incomplete.

And whereas Ugu District Municipality has had to extend its contract with Sanitech a Division of Waco Africa for the Supply and Delivery of Mobile Toilets at Umzinto Informal Settlement for a further period of six (06) months from 01 March 2025 to 30 September 2025, under contract number UGU-07-1390-2016 as per letter of extension marked Annexure "H" in order to avoid service disruption and health risks to the beneficiaries.

And whereas Umdoni Local Municipality has obtained authorisation from the Department of Human Settlements to continue to utilise the funds from the Umdoni Municipality- Municipal Housing Operational account in order to make payment to Ugu District Municipality for sanitation services rendered for Umzinto informal settlements per letter marked "Annexure I".

And Whereas the Parties intend to amend the terms and conditions of the said Principal Agreement by making the following amendments:

Whereas the KwaZulu-Natal Department of Human Settlements and Umdoni Local Municipality have the Umzinto Siums Clearance that aims to eradicate informal settlements within Umzinto area ward 11,12 and 13 in Umdoni Local Municipality. In terms of the project and as at July 2020 over 500 units of the Phase1A have been completed however a large number of beneficiaries are still living in the informal settlements requiring interim services. The Umzinto Slums Project is wholly funded the KZN Department of Human Settlements.

Whereas Umdoni Local Municipality has made an application for funding to the Department of Humans Settlement for the provision of Interim services to the Umzinto Informal Settlement as the KZN Department of Human Settlements advised that the funding for interim services in Informal Settlement is only availed to Local Municipalities. As at August 2023 the KZN Department of Human Settlement requested a period of six months to avail the funding to Umdon! Local Municipality.

Whereas Ugu District Municipality is providing the interim services to the Umzinto Informal Settlements which it has been providing and paving for the said provisions of these interim services since its appointment of a service provider Sanitech a Division of Waco Africa (PTY) LTD in December 2016, a contract that was awarded and was agreed to be for a period of thirty-eix (36) months which has been extended on a month-to-month basis since December 2019 to date.

Whereas the MEC for Transport and Human Settlements for KwaZulu-Natal has on 29th August 2024 approved the project for the provision of sanitation service to Umzinto Informal Settlements through the Municipal Housing Operational Account (MHOA).

Whereas the utilization of Municipal Housing Operational Account (MHOA) funds of R2 380 987.81 located at uMdoni Local Municipality for the procurement of sanitation services for the Informal settlements in uMdoni for a period of 3-6 months.

Whereas Ugu District Municipality will access these funds from Umdoni Local Municipality and continue to provide the interim services for a further period of six months from 01 September 2024 to 28 Fabruary 2025 with the service provider referred to above thereafter the contract between Ugu DM and the service provider will be terminated.

1. DEFINITIONS

1.3 'DHS'	means the KwaZulu-Natal Department of Human Settlements.
1.4 Constitution	means the Constitution of the Republic of South Africa Act 103 of 1995.
1.5 "Structures Act"	means the Local Government Municipal Structures Act 117 of 1996
1.9 Systems Act	means the Local Government: Municipal Systems Act 32 of 2000
1.7 "Working Day"	means any day from Monday to Friday, excluding Saturdays, Sundays, Public holidays and refers to a shift working day

- 2.6 This Agreement shall be interpreted and applied in accordance with South African laws.

of cooperative governance that Ugu District Municipality assist with the provision of interim services to the informal settlement for a period of thirty-six months (36) in which time Umdoni Local Municipality and the Department of Human Settlements were to finalise the Umzinto Siurns Clearance thereby eradicating informal settlements in the Umzinto area thereby eradicating beneficiaries requiring interim services.

- 3.3 Ugu District Municipality appointed a service provider Senitsch a Division of Waco Africa (PTY) LTD for Supply and delivery of Mobile Tollets at Umzinto Informal Settlements for a period of Thirty-Six (36) Months, contract number: UQU-07-1390-2016 as per Letter of Award marked Annexure "A".
- 3.4 As at July 2020 and over 42 months into the above contract the Department of Fluman Settlements and Umdoni Local Municipality had not completed the Umzinto Siums Clearance project and thus a large number of beneficiaries in the Umzinto Informal Settlement were still in need of interim services.
- in a meeting held on 23 July 2020 between Ugu District Municipality, Umdoni Local Municipality and the Department of Human Settlements KZN, the DHS (KZN) advised that it has funding in a form of grant for the provision of interim services for informal Settlements available only for Local Municipality's. It was resolved in that meeting that Umdoni Local Municipality would make an application for the funding/ grant with the Department of Human Settlement.
- 3.6 Umdon't Local Municipality, with the assistance of Ugu District Municipality, made an application dated 31 July 2020 for said funding from the Department of Human Settlement. The Department of Human Settlement advised that they require a period of six (6) months to allow for their processes to avail the funding to Umdon't Local Municipality. See Annexure marked "B".
- 3.7 It was agreed that Ugu District Municipality would continue to provide the mobile tollets for a further period of abr-months to accommodate the ebr-month period requested by DHS(KZN).

- 3.8 It was further agreed that at Umdoni Local Municipality would take of the provision of the interim services/mobile toilets at the end of the sbr-month period referred to in 3.7 above.
- Over the years and between 2020 to 2023 there have been numerous discussions by Ugu District Municipality and Umdoni Local Municipality to facilitate the transition of the provision of the interim services from UDM to ULM resulting in the UDM Council taking a resolution that the provision of these interim services be transferred to Umdoni Local Municipality. See Annexure "C."
- 3.10 To date, August 2023, Ugu Dietrict Municipality is still providing and paying for the interim services for the beneficiaries in Umzinto Informal Settlements on a month-to-month basis since December 2019 with the understanding that the Department of Human Settlement (KZN) is soon to svall the funding to Umdoni Local Municipality wherein Umdoni Local Municipality would take over the provision of the interim services.
- 3.11 The Department of Human Settlement advised Umdoni Local Municipality that it had received its application for funding and that it required a period of six months from 01 August 2023 in order to finalize its processes and avail the funding to Umdoni Local Municipality.
- 3.12 Ugu District Municipality agrees to extend the contract for the provision of mobile tollets to Umzinto Informal Settlement with Sanitsch a Division of Waco Africa (PTY) LTD for a further period of six months from 1 August 2023 to 31 January 2024 thereafter Umdoni Local Municipality will take over the provision of interim services to Umzinto Informal Settlement.
- 3.13 Ugu District Municipality was, on or about January 2024, informed by the KwaiZulu-Natal DHS that the procurement process for taking over the services with Umdon! Local Municipality had not been finalized and requested that Ugu DM extend the contract with the service provider.

- 3.14 Ugu District Municipality extended the contract from January 2024 to June 2024 and again from July 2024 to August 2024 as the status referred to in 3.13 remained the same.
- 3.15 On the 29^{th of} August 2024 the MEC for Transport and Human Settlements for KwaZulu-Natal approved the project for the provision of sanitation service to Umzinto Informal Settlements through the Municipal Housing Operational Account (MHOA) on the terms and conditions as set out in Annexure "D" and Annexure "E" respectively.
- 3.18 Ugu District District Municipality will extend the contract from 01 September 2024 to 28 February 2025 and Umdoni Local Municipality will through the MHCA funds as approved by the MEC pay Ugu DM monthly for the services who will in turn pay the service provider for the provision of these services. Thereafter the contract between Ugu DM and the service provider will be terminated.

A. DURATION

4.1 This Agreement shall commence on @1 September 2024 and shall subsist until 28 February 2025.
