PUBLIC NOTICE TO ALL PROPERTY OWNERS TO APPLY FOR RATES RELIEF MUNICIPAL NOTICE NO: 180 / 2024

CATEGORY OF OWNER

- Pensioners (defined in terms of Councils' Rates Policy)
- Disabled persons, not gainfully employed
- Retirees
- Indigents (defined in terms of Councils' Indigent Policy)
- Child headed households (deceased, terminally ill or absent parents)

RELIEF

In terms of the Rates Policy, relief measures are applicable as follows:

- The relief is a further reduction of R295 000 on the property value;
- indigents will be fully subsidized for refuse removal; and
- a maximum of 50kWh per month on electricity usage.

CRITERIA

- In the case of pensioners, household income threshold as determined by SASSA (as 01 April 2024):
 - Single person – R 97 320.00 annually
 - Married person – R 194 640.00 annually
- In the case of indigents, the monthly household gross income must be equal or less than two (2) state welfare pensions per the SASSA grant schedule as 01 April 2024 (R2100pmx2 = R4200pm)
- Sole owner (or jointly with spouse)
- Living permanently on property
- Not own any other property
- Proof of income to be provided
- Proof of identity to be provided

CATEGORY OF ORGANISATION

- Non-profit Organisation
- Place of Worship
- Public Benefit Organisation

CRITERIA

- Proof of registration as a public benefit organization; and
- Tax exemption certificate issued by the South African Revenue Services (SARS) in terms of the requirements of the Income Tax Act;
- NPO/PBO number
